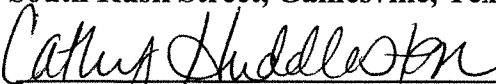

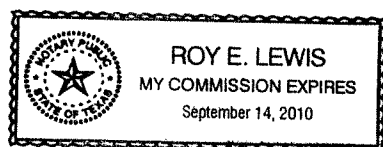
The Building and Standards Commission may convene into Executive Session to discuss posted items as allowed by the Texas Open Meetings Act, Local Government Code Section 551.071.

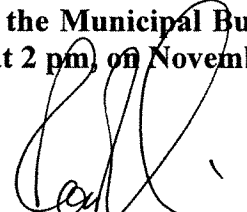
Agenda items may be taken in any order at the discretion of the chair.
